Financial Report for January 2024

Our organization was privileged to help a total of 3 veterans' families for Christmas. Chappy came in under budget, spending \$2,061.34 of the \$2,100.00 allowable. Thanks to a generous donor, we were able to replace the wood furnace in the main building at no cost to the organization. We received generous donations to add to the building fund. A single donation from VFW Post 748 for \$20,000, along with other donations received from individuals and from the Indiana Patriot Guard brought the total in the building savings account to \$57,980.64. We will be working from a budget for the 2024 fiscal year which will help to guide us to be frugal and fiscally sound. I want to thank the new board for all their efforts to make the transition of the administration smooth, allowing all to work for the best interests of our organization. As always, I am happy to answer any questions (in the office) you might have regarding finances.
